1. The grant for recognition is not extendable and does not in any way imply any obligation to recognize or affiliate the school beyond Class VIII.
2. The school shall abide by the provisions of Right of Children to Free and Compulsory Education Act, 2009 (Annexure-I) and Right of Children to Free and Compulsory Education Rules, 2011 (Annexure-II).
3. The Society /School shall not collect any capitation fee and subject the child his or her parents or guardians to any screening procedure.
4. The School shall not deny admission to any child.
 - (I) for lack of age proof.
 - (II) If such admission is sought subsequent to the extended period of ninety days for admission; and
 - (III) on the ground of religion, caste or race, place of birth or any of them.
5. The School shall ensure that;
 - (I) No child admitted shall be held back any class or expelled from school till the completion of elementary education in that school.
 - (II) No child shall be subjected to physical punishment or mental harassment;
 - (III) No child is required to pass any board examination till the completion of elementary education;
 - (IV) Every child completing elementary is awarded a certificate as laid down under rule 19 of the Right of children to free and compulsory Education, Himachal Pradesh Rules, 2011.
 - (V) Student with disabilities /special need is given admission as per provision of the Act.
 - (VI) The teachers are recruited with minimum qualification as laid down under section 23(1) of the Act the current.
 - (VII) The teacher perform his/ her duties specified under section 24(1) of the Act and.
 - (VIII) The teacher shall not engage himself for private teaching activities.
6. The school shall follow the syllabus on the basis of curriculum laid down by academic authority under sub-section 19 of the Act,
7. The School shall enroll students proportionate to the facilities available in the school specified in the Section (1) of Section 29.

9. No unrecognized classes shall run within the premises of the school or outside in the name of school.
10. The school buildings or other structures or the grounds shall not be uses during the day or night for commercial or residential purposes, except for the purpose of residence of any employee of the school or for political or non-educational activity of any kind whatsoever.
11. The School shall be run by a society registered under the societies Registration Act, 1860(21 of 1860), or a public trust constituted under any law for the time being in force.
12. The School shall not be run for profit to any individual, group or association of individuals or any other person.
13. The account of the school shall be audited and certified by a chartered Accountant and proper account statements shall be prepared as per rule. A copy each of the statements of Accounts shall be sent to the Deputy Director Elementary Education officers every year.
14. The recognition Code Number allotted to your school is BHARMOUR-104 this may please be noted and quoted for any correspondence with this office.
15. The School shall furnish such reports and information as may be required by the Director of Education/ Deputy Director of Elementary Education officer from time to time and comply with such instructions of the State Government/local authority as may be issued to secure the continued fulfilment of the condition of recognition or the removal of definiencies in working of the school.
16. Renewal of Registration of society if any be ensured.
17. The State Government may specify additional conditions from time to time, for compliance

The School shall Submit their self declaration form for renewal the affiliation on form No-1 along with Challan form of Rs.500/- Every Year in the month of March.
